

Privacy Notice (How we use your information)

Infection Prevention and Control Service

The categories of information that we collect, process, hold and share include:

- Personal information
- Name
- Age
- Date of Birth
- Address
- GP
- NHS number
- Characteristics (such as gender, ethnicity and disability)
- Social Circumstances
- Health/Public Health Information

How we receive the personal information:

We receive personal information indirectly from organisations relevant to you

Why we collect and hold this information:

We use this personal data in order to:

- provide you with an effective Infection Prevention and Control Service
- provide you with the support you need to manage infections
- enable us to manage cases, clusters & outbreaks of communicable disease & to undertake post infection reviews
- assess the quality of health and social care services
- assess health inequalities across service
- evaluate and improve health and social care performance
- derive statistics which inform decisions about future delivery of health and social care services
- enable Wirral Community Health and Care NHS Foundation Trust to meet its legislative duties
- prevent the spread of communicable diseases
- satisfy statutory requirements

Under the UK General Data Protection Regulation (GDPR) the legal bases we use for processing this information is:

GDPR Article 6(1)(e) 'processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority...'

GDPR Article 9(2)(j) '...necessary for reasons of public interest in the area of public health...or ensuring high standards of quality and safety of health care and of medicinal products or medical devices...'

Storing this information:

We will hold the information about you securely, and for no longer than reasonably necessary. We will hold it in line with record retention guidance in order to comply with statutory requirements after which it will be securely destroyed.

Who we share this information with:

We will share the information about you necessary for reasons of public interest in the areas of public health.

 Other services within Wirral Community Health and Care NHS Foundation Trust relevant to you.

Why we share this information:

We share information with our partners on a statutory basis. This is in order to:

- enable other services to deliver correct and effective treatment
- appropriately manage infections & infectious disease
- prevent & control the spread of communicable disease
- identify any lapses in care and promote learning

We do not share personal information about you with anyone else without consent unless the law and our policies allow us to do so.

Your data protection rights:

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
